## **Information note provided pursuant to artt. 13-14 of the GDPR (General Data Protection Regulation) 2016/679**

According to the above mentioned law, the processing of the data will be based on the principles of fairness, lawfulness, transparency and protection of your confidentiality and your rights. According to article 13 of the GDPR 2016/679, therefore, we provide you with the following information:

The data acquired through the video recording will be subject to the processing in particular for:

- Staff security
- Protection of the real estate

The provision of the data based on the legitimate interest is mandatory and strictly instrumental to accessing the area and in case of failure to provide it, it will not be possible to access.

The data may be disclosed only to public entities entitled to request the data, such as the judicial and / or public security authority.

The display and management of the images taken through the video surveillance system are reserved to the controller of the data processing or to the persons formally appointed by him. The data is stored using appropriate security measures to prevent access by unauthorized personnel and to guarantee its confidentiality and integrity.

The images contained in the video recordings are kept, for maximum 24 hours after the recording, except cases of special needs for further storage in case we have to comply with a specific investigative request made by the judicial authority or by the police. After this deadline, the images will be automatically deleted.

The images in real time are also visible on a special monitor inside the facility, which is used by the internal staff as a videophone.

The data subject (ie the person who believes to have been filmed) may exercise towards the controller all the rights provided for by Article 15 et seq. of the European Regulation. In particular:

- ask the controller to access the images
- oppose the processing;
- request the limitation of the processing and / or the cancellation where applicable.

The right of updating or integration is not exercisable, as well as the right of rectification referred to in Article 16 of the GDPR in consideration of the intrinsic nature of the processed data (images collected in real time concerning an objective fact).

The right to the portability of the data referred to in Article 20 of the GDPR is not exercisable, as the images acquired with the video surveillance system cannot be transferred to other subjects (except legitimate public subjects).

The interested party may request to view the images in which he / she believes to have been filmed by showing, or attaching to the written request addressed to the data controller, appropriate identification documents.

The response to a request of access cannot include any possible data relating to third parties, unless the breakdown of the data processed or the elimination of some elements make the personal data relating to the interested party incomprehensible.

Once the aforementioned storage terms have expired, it will be impossible to satisfy the request of access.
